**ANNUAL PLAN FOR PHA FY 2023 [FFY 2022], beginning April 1, 2022**

**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA’s operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA’s mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** The Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

If using Project-Based Vouchers (PBVs), provide the projected number of project-based units and general locations, and describe how project basing would be consistent with the PHA Plan.</p> <p><b>Conversion of Public Housing to Project-Based Assistance under RAD.</b> <i>No further conversion activities were planned or underway when this Plan amendment was written</i></p> <p><b>History:</b> <i>On October 3, 2019 the PHA closed on 8 RAD conversions, removing 3,855 units from public housing and converting 3,836 to Project-Based Rental Assistance (PBRA) under HUD's Multifamily Housing division. (19 units used for non-dwelling purposes were not included in the PBRA HAP Contracts.) The PBRA HAP contracts were effective January 1, 2020. Together the eight RAD conversion applications constituted a near-portfolio-wide conversion including all of the PHA's the sixteen hi-rises and four family housing developments. The PHA's 418 scattered site homes were not part of these RAD applications; they remain as public housing.</i></p> <p><b>Pending Disposition Activities:</b> <i>No disposition activities were planned or underway when this Plan amendment was written. Over the next year or two the PHA will hold discussions with residents, elected officials and community stakeholders about the best ways to preserve the 418 scattered site homes and duplex units as safe, affordable, quality housing for low income families. The PHA would request replacement Housing Choice Vouchers or other replacement housing if any scattered site homes are proposed to be sold to current residents or others.</i></p> <p><i>(As explained in Attachment E, HUD's Special Applications Center (SAC) approved the PHA's request to release HUD's Declaration of Trust (DOT) for the W. Andrew Boss Building (located at 555 North Wabasha Street in St. Paul) which has been on file in the Ramsey County Property records. The DOT release will be finalized after the RAD conversions are completed. This is not a property disposition; the PHA will sign a "Use Restriction" binding it to continue using the property for its current purposes for not less than 30 years.)</i></p> <p><b>Project-Based Vouchers (PBV):</b> <i>Staff expects to present recommendations at the February 23, 2022 Board meeting for the next round of awards of Project-Based Vouchers (PBVs), from applications submitted to Minnesota Housing (Minnesota Housing Finance Agency) in response to that agency's 2021 Consolidated Requests for Proposals (RFP). On April 28, 2021, the PHA Board approved offering 50 PBVs in the 2021 Consolidated RFP, with an additional 20 available for VASH. Following PHA policy, these were advertised through Minnesota Housing, and interested housing developers/owners submitted applications</i></p>

	<p>directly to Minnesota Housing. Once Minnesota Housing has made their funding awards, which is expected to occur in January 2022, staff will review the proposals that were awarded funding by from Minnesota Housing and those that only applied for PBVs through the Consolidated RFP. On January 27, 2021, the Board awarded a total of 115 Housing Choice Vouchers/Section 8 vouchers for PBV use in four developments. (On June 24, 2020, the Board approved offering up to 120 PBVs in Minnesota Housing's 2020 Consolidated RFP; applications requesting 123 PBVs were received.) As of October 27, 2021 two of the projects (with 31 vouchers) had signed their Housing Assistance Payment (HAP) contracts, and the other two projects (84 vouchers) were still in development.</p> <p><b>Emergency Housing Vouchers (EHV):</b> On July 28, 2021, the Board approved the PHA's acceptance of 157 Emergency Housing Vouchers (EHV), and also agreed to enter into a Memorandum of Understanding with the Continuum of Care (Heading Home Ramsey or "HHR") to help administer these vouchers.</p> <p><b>Choice Mobility Vouchers (CMV):</b> On September 22, 2021 the Board approved policies for administering Choice Mobility Vouchers. These are Housing Choice Vouchers (HCV) from the PHA's existing allocation, which may be requested by residents of the PHA's Multifamily Housing properties after 2 years' residence in the same unit/project. The first residents will become eligible on January 1, 2022 (2 years after the effective date of the RAD conversion to PBRA). Due to low turnover of HCVs, most residents requesting a CMV will go on a waiting list</p>

A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154; or 24 CFR 5.160(a)(3) as applicable (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction’s initiatives to affirmatively further

fair housing that require the PHA's involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations. impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction's initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.
