Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

If using Project-Based Vouchers (PBVs), provide the projected number of project-based units and general locations, and describe how project basing would be consistent with the PHA Plan.</p> <p>Mixed Finance Development and Conversion of Public Housing to Project-Based Assistance under RAD. <i>As explained in Attachments I and J, when this Plan amendment was written the PHA was making plans to construct new "in-fill" units at McDonough Homes and Dunedin Terrace, using funds awarded by Ramsey County, MN.</i></p> <p>RAD History: <i>On October 3, 2019 the PHA closed on 8 RAD conversions, removing 3,855 units from public housing and converting 3,836 to Project-Based Rental Assistance (PBRA) under HUD's Multifamily Housing division. (19 units used for non-dwelling purposes were not included in the PBRA HAP Contracts.) The PBRA HAP contracts were effective January 1, 2020. Together the eight RAD conversion applications constituted a near-portfolio-wide conversion including all of the PHA's the sixteen hi-rises and four family housing developments. The PHA's 418 scattered site homes were not part of these RAD applications; they remain as public housing.</i></p> <p>Pending Disposition Activities: <i>No disposition activities were planned or underway when this Plan amendment was written.</i></p> <p>Project-Based Vouchers (PBV): <i>Staff expects to review options for a future PBV offering at the January 25, 2023 Board meeting. On May 25, 2022, the PHA Board approved offering 40 PBVs in the 2022 Consolidated RFP, exclusively for HUD-VASH vouchers for homeless veterans. Following PHA policy, these were advertised through Minnesota Housing, and interested housing developers/owners were invited to submit applications directly to Minnesota Housing. Once Minnesota Housing has made their funding awards, staff typically review the proposals that were awarded funding by Minnesota Housing and those that only applied for PBVs through the Consolidated RFP. However, there were no eligible PBV applications in this cycle, as Minnesota Housing did not fund an otherwise eligible project.</i></p> <p><i>On April 27 and May 25, 2022, the Board awarded a total of 61 Housing Choice Vouchers/Section 8 vouchers for PBV use in two developments. Those applications were submitted in response to the 2021 Consolidated RFP.</i></p> <p>Mainstream Vouchers: <i>On August 24, 2022, the Board approved the PHA's acceptance of 30 more Mainstream Vouchers.</i></p>

	<p>Stability Housing Vouchers: On September 20, 2022, the PHA submitted a “registration of interest” stating that it would accept Stability Vouchers if awarded by HUD.</p> <p>Choice Mobility Vouchers (CMV): These are Housing Choice Vouchers (HCV) from the PHA’s existing allocation, which may be requested by residents of the PHA’s Multifamily Housing properties after 2 years’ residence in the same unit/project. The first residents became eligible on January 1, 2022 (2 years after the effective date of the RAD conversion to PBRA). Due to low turnover of HCVs, most residents requesting a CMV go on a waiting list.</p> <p>Units with Approved Vacancies for Modernization: The PHA will continue to hold some scattered site homes vacant upon turnover, to allow significant repair/renovation/modernization work to be completed without relocating residents. (For example, major plumbing and electrical upgrades that require disconnecting the services, replacing kitchen or bathroom flooring and fixtures that render the rooms unusable for days at a time, etc.) Staff plan ahead for this construction work by including significant amounts in annual budgets (Capital Fund Program grants and Operating Budget), but the work is not started until the home actually becomes vacant. As that occurs, staff asks HUD approval to designate the unit “Vacant Undergoing Modernization”.</p>

This includes all certifications relating to Civil Rights and related regulations. A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154; or 24 CFR 5.160(a)(3) as applicable (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction’s initiatives to affirmatively further fair housing that require the PHA’s involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or

consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations. impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction's initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. (24 CFR §903.7(o)).

Until such time as the PHA is required to submit an AFH, the PHA will not have to complete section D., nevertheless, the PHA will address its obligation to affirmatively further fair housing by fulfilling the requirements at 24 CFR 903.7(o)(3) enacted prior to August 17, 2015, which means that it examines its own programs or proposed programs; identifies any impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; and maintain records reflecting these analyses and actions. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.

Public reporting burden for this information collection is estimated to average 7.02 hours per response, including the time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information. HUD may not collect this information, and respondents are not required to complete this form, unless it displays a currently valid OMB Control Number.
